

“CARMAX DRIVE WHAT’S POSSIBLE SCRATCH & WIN SWEEPSTAKES”

OFFICIAL RULES

NO PURCHASE OR PAYMENT IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT IMPROVE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED AND OUTSIDE THE ELIGIBILITY AREA DEFINED BELOW.

DISTRIBUTION PERIOD, GAME PLAY PERIOD & SPONSOR: The “CarMax Drive What’s Possible Scratch & Win Sweepstakes” (“**Sweepstakes**”) **Distribution Period (defined below)** starts at 5:00 pm Pacific Time (“**PT**”) on 10/24/17 and ends at the earlier of 9:00 pm PT on 10/24/17 or when the supplies of specially marked Sweepstakes game cards (each a “**Game Card**” and collectively “**Game Cards**”) have been exhausted, whichever comes first (“**Distribution Period**”). The Game Play Period (defined below) starts at 5:00 pm PT on 10/24/17 and ends at 11:59 pm PT on 11/30/17 (“**Game Play Period**”).

The sponsor (“**Sponsor**”) of the Sweepstakes is CarMax Business Services, LLC, 12800 Tuckahoe Creek Parkway, Richmond, VA 23238. The Sweepstakes is subject to these official rules (the “**Official Rules**”) and by entering, entrant agrees to be bound by the terms and conditions herein and to all applicable federal, state and local laws.

ELIGIBILITY: Sweepstakes is open only to legal residents of the following California, USA counties: Imperial, San Diego, Riverside, Orange, San Bernardino, Los Angeles, Ventura, Kern, Santa Barbara, San Luis Obispo, Inyo, Tulare and Kings (collectively, the “**Eligibility Area**”), who as of the date of their Game Play (defined below) into the Sweepstakes are eighteen (18) years of age or older. Employees, officers and directors of Sponsor, Wasserman Media Group, LLCLA Clippers LLC (the “**LA Clippers**”), NBA Entities (as defined below) and each of the foregoing entities’ affiliates, and any other Sponsor-authorized designees associated with the design, administration, prize supplying or prize fulfillment of the Sweepstakes (collectively, the “**Sweepstakes Entities**”), as well as members of such employees’, officers’ or directors’ immediate families (spouses, children, siblings, parents, grandparents, grandchildren, legal guardians, in-laws) or household members of each employee (whether or not related), are not eligible to participate in the Sweepstakes. The Sweepstakes is void outside the Eligibility Area and where prohibited by law.

Normal Internet access, phone, and usage charges imposed by your online or phone service may apply.

HOW TO PLAY THE GAME: During the Distribution Period and while supplies last, eligible entrants must acquire one (1) Carmax Drive What’s Possible Scratch & Win Game Card from LA Clippers event staff (Guest Services Relations) personnel as they enter the LA Clippers home game at the Staples Center in Los Angeles, CA, Only one (1) Game Card will be provided to each eligible individual. Game Cards will be handed out until 9:00 pm PT on 10/24/17 or until the available supply of specially marked Game Cards are exhausted, whichever occurs first.

Once you have received a Game Card, scratch off the silver material on the Game Card to reveal a unique code (“**Code**”). To see if your Game Card contains a winning Code, during the Game Play Period visit the website at justscratchit.com/carmax (“**Sweepstakes Site**”) and follow the directions for Game Play by inputting your personal information (full name, email address, zip code, and date of birth) and the Code, agreeing to the Official Rules and clicking “Submit.” By successfully completing the foregoing and subject to the game play limitations and eligibility conditions detailed herein, you will have received a “**Game Play**” in the Sweepstakes. **NOTE: THERE IS A LIMIT OF ONE (1) GAME PLAY PER PERSON PER EMAIL ADDRESS FOR THE SWEEPSTAKES. ANY ATTEMPTED GAME PLAYS IN EXCESS OF THAT LIMIT SHALL BE DEEMED VOID.**

Each individual submitting a Game Play may be referred to as an “**Entrant**.”

Any attempt by any Entrant to submit more Game Plays than the stated number by using multiple/different email addresses, identities, registrations and logins, or any other impermissible methods will void that Entrant’s Game Play and that Entrant may be disqualified, at the sole discretion of Sponsor. Use of any automated system to participate in the Sweepstakes is prohibited and will result in disqualification. Sponsor is not responsible for lost, late, stolen, damaged, misdirected, undelivered, garbled, illegible, or otherwise defective, deficient or impermissible Game Plays, for postage-due mail, or for computer hardware or software failures, malfunctions, errors or difficulties of any kind, whether human, electronic, computer, mechanical, network, typographical, printing or otherwise relating to or in connection with the Sweepstakes, including, without limitation, errors or difficulties which may occur in connection with the administration of the Sweepstakes, the processing of Game Plays, the announcement or notification of the prizes or in any Sweepstakes-related materials.

GAME PLAY WINNER DETERMINATION: After completing your Game Play, you will receive a notification email at the email address you submitted at the time of your Game Play indicating if you are a prize winner and if so, the actual prize won or if you are not a winner, a discount promotional coupon to ClippersStore.com as detailed below. In this notification email you will also receive instructions on how to claim your prize or discount. **NOTE: unclaimed prizes will NOT be awarded.**

All federal, state and local tax liabilities, if any, are the responsibility solely of the prize winners. Approximately 15,000 Game Cards will be available for distribution in the Sweepstakes. The overall odds of receiving a winning Game Card are 1:19.74 (i.e 1:20). Specific odds associated with each level of prize is provided above. Number

of prizes available will diminish as they are awarded. Some prizes may be claimed before the end of the Sweepstakes, and Sweepstakes Entities disclaim all liability for continuing to advertise such prizes after they have been awarded. Participants with non-winning Game Cards will receive a discount promotional coupon good for redemption at Clippersstore.com. **NOTE: all redemptions at Clippersstore.com (whether a gift card/certificate or discount coupon) must be completed by 11:59 pm PT on 11/30/17.** After this time redemptions will be null and void. Note: the entirety of the prize gift certificate/card or discount must be used in a single transaction at the same time. Additional terms may apply to the gift card/certificate and/or discount coupon; see gift card/certificate or coupon for more information.

As outlined above, winners will be notified via email that they have won a prize. In addition, the potential Grand Prize winners will receive a second email notification directly by Sponsor or its representative by email within seven (7) days of the conclusion of the Sweepstakes Period and will be required to respond to such notification and verify eligibility in the Sweepstakes within the time limit stated at time of notification or prize will be forfeited. marks, or logos, Sponsor and/or LA Clippers reserve the right to terminate the Prize early, and send Grand Prize winner and/or Guest home with no further obligations or compensation whatsoever to Grand Prize winner and/or Guest (which may, in Sponsor's sole discretion, result in such Grand Prize winner's disqualification from the Sweepstakes and forfeiture of any (and/or all) Prize(s)). In the event Grand Prize winner or Guest engages in behavior during the Game or in any Prize-related activity that (as determined by Sponsor and/or LA Clippers in their sole discretion) is illegal, tortious, or subjects Grand Prize winner or Guest to arrest or detention, Sponsor and LA Clippers shall have no obligation to pay any damages, fees, fines, judgments or other costs or expenses of any kind whatsoever incurred by Grand Prize winner or Guest as a result of such conduct. Sponsor and LA Clippers shall have no liability for any personal injuries, death, property damage, or other damages or expenses resulting from or arising out of any travel related to the Grand Prize or any other aspect of Grand Prize winner's or Guest's acceptance or use of the Grand Prize.

All prizes may be referred to hereafter individually as a "**Prize**" and collectively as "**Prizes**". The total ARV of all Prizes to be awarded in the Sweepstakes is \$54,000. There is a limit of one (1) Prize per person/household address for the Sweepstakes.

Awarding of the Prizes is subject to the Prize winners' acceptance of all requisite conditions within these Official Rules and each Prize winner's ability and agreement to grant the rights set forth in these Official Rules and all required documents detailed herein. RELEASES: The Sweepstakes Entities, and any and all Internet server(s) and access provider(s), and each of their respective affiliates, subsidiaries, parent corporations, and advertising and promotion agencies, and all of their officers, directors, shareholders, employees and agents (collectively, "**Releasees**") are not responsible for: any incorrect or inaccurate submitted information submitted at time of Game Play; human errors; technical malfunctions; failures, omissions, interruptions, deletions or defects of any telephone network, computer online systems, computer equipment, servers, providers, or software, including without limitation any injury or damage to participant's or any other person's computer relating to or resulting from participation in the Sweepstakes; inability to access the Sweepstakes Site; inability to receive emails from Sponsor or its representatives, theft, tampering, destruction, or unauthorized access to, or alteration of, Game Plays; data or Prize claims that are processed late or incorrectly or are incomplete or lost due to telephone, computer or electronic malfunction or traffic congestion on telephone lines or the Internet or any web site or for any other reason whatsoever; typographical, printing or other errors; any other Sweepstakes related materials which are late, lost, incomplete, misdirected, stolen, mutilated, illegible, or or any combination thereof. GOVERNING LAW/LIMITATION OF LIABILITY: The internal substantive laws (as distinguished from the choice of law rules) of the Commonwealth of Virginia and the United States shall govern the validity and interpretation of these Official Rules and all other causes of action (whether sounding in contract or in tort) arising out of or relating to the Game or these Official Rules. By participating in the Sweepstakes, participants hereby submit to the jurisdiction and venue of the federal and state courts of the Commonwealth of Virginia and waive the right to have disputes arising out of the subject matter hereof adjudicated in any other forum.

BY SUBMITTING A GAME PLAY IN THE SWEEPSTAKES, ENTRANT AGREES THAT TO THE EXTENT PERMITTED BY APPLICABLE LAW: (1) ANY AND ALL DISPUTES, CLAIMS AND CAUSES OF ACTION ARISING OUT OF OR CONNECTED WITH THE SWEEPSTAKES, OR ANY PRIZE AWARDED, WILL BE RESOLVED INDIVIDUALLY, WITHOUT RESORT TO ANY FORM OF CLASS ACTION; (2) ANY AND ALL CLAIMS, JUDGMENTS AND AWARDS WILL BE LIMITED TO ACTUAL THIRD-PARTY, OUT-OF-POCKET COSTS INCURRED (IF ANY) NOT TO EXCEED FIFTY DOLLARS (\$50.00), BUT IN NO EVENT WILL ATTORNEYS' FEES BE AWARDED OR RECOVERABLE; (3) UNDER NO CIRCUMSTANCES WILL ANY ENTRANT BE PERMITTED TO OBTAIN ANY AWARD FOR, AND ENTRANT HEREBY KNOWINGLY AND EXPRESSLY WAIVES ALL RIGHTS TO SEEK, PUNITIVE, INCIDENTAL, CONSEQUENTIAL OR SPECIAL DAMAGES, LOST PROFITS AND/OR ANY OTHER DAMAGES, OTHER THAN ACTUAL OUT-OF-POCKET EXPENSES NOT TO EXCEED FIFTY DOLLARS (\$50.00), AND/OR ANY RIGHTS TO HAVE DAMAGES MULTIPLIED OR OTHERWISE INCREASED; AND (4) ENTRANTS' REMEDIES ARE LIMITED TO A CLAIM FOR MONEY DAMAGES (IF ANY) AND ENTRANT IRREVOCABLY WAIVES ANY RIGHT TO SEEK INJUNCTIVE OR EQUITABLE RELIEF. SOME JURISDICTIONS DO NOT ALLOW THE LIMITATIONS OR EXCLUSION OF LIABILITY, SO THE ABOVE MAY NOT APPLY TO YOU.

FORCE MAJEURE: Releasees shall not be liable to the Prize winners or any other person for failure to supply a Prize or any part thereof, by reason of any acts of God, any action(s), regulation(s), order(s) or request(s) by any governmental or quasi-governmental entity (whether or not the action(s), regulation(s), order(s) or request(s) prove(s) to be invalid), equipment failure, terrorist acts, earthquake, war, fire, flood, explosion, unusually severe weather, hurricane, embargo, labor dispute or strike (whether legal or illegal), labor or material shortage, transportation interruption of any kind, work slow-down, civil disturbance, insurrection, riot, network or computer problems, internet problems, hacking, computer viruses, unauthorized computer access, tampering, or any other cause beyond Releasees control.

GENERAL CONDITIONS: If for any reason this Sweepstakes is not capable of running as planned, or if this Sweepstakes or any web site associated therewith (or any portion(s) thereof) becomes corrupted or does not allow the proper playing of the Sweepstakes and processing of Game Plays in accordance with these Official Rules, or if infection by computer virus, bugs, tampering, unauthorized intervention, actions by Entrants (or others), fraud, technical failures, or any other causes, in the Sponsor's sole opinion, corrupts or affects the administration, security, fairness, integrity, or proper conduct of this Sweepstakes, the Sponsor reserves the right, at its sole discretion, to disqualify any individual implicated in such action and/or to cancel, terminate, modify, or suspend this Sweepstakes or any portion thereof. In the event the Sweepstakes is cancelled, and to the extent possible (such determination to be made by Sponsor), Sponsor will conduct random drawings to select the stated number of Prize-winning Entrants from among all eligible, non-suspect Game Plays received, prior to the time of the action or event warranting such cancellation, and to award the stated number of Prizes (or any awardable portion(s) thereof). In the event that Sponsor determines that there are no eligible Entrants, Sponsor reserves the right in its sole discretion to not award any of the Prizes (or any portion thereof) or less than the stated number of Prizes. If such cancellation, termination, modification, or suspension occurs, notification will be posted at Sweepstakes Site. The Releasees are not responsible for the actions of Entrants in connection with the Sweepstakes, including Entrants' attempts to circumvent the Official Rules or otherwise interfere with the administration, security, fairness, integrity or proper conduct of the Sweepstakes. Persons found tampering with or abusing any aspect of this Sweepstakes, or whom Sponsor believes to be causing malfunction, error, disruption or damage may be disqualified. Additionally, any attempt to cheat the Sweepstakes, as determined at the sole and absolute discretion of Sponsor, may result in immediate disqualification of the Entrant, as well as other possible consequences, including disqualification from any and all existing and future sweepstakes, contests or other promotions. ANY ATTEMPT BY AN ENTRANT OR ANY OTHER INDIVIDUAL TO DAMAGE ANY WEB SITE, OR UNDERMINE THE LEGITIMATE OPERATION OF THE SWEEPSTAKES IS A VIOLATION OF CRIMINAL AND/OR CIVIL LAWS AND SHOULD SUCH AN ATTEMPT BE MADE, THE SPONSOR RESERVES THE RIGHT TO SEEK DAMAGES AND OTHER REMEDIES FROM ANY SUCH PERSON TO THE FULLEST EXTENT PERMITTED BY LAW.

Multiple Entrants may not share the same email address. If a dispute arises about who submitted a Game Play, the Game Play will be deemed submitted by the authorized account holder of the email address entered. The authorized account holder of the email address is deemed the natural person who is assigned to an email address by an Internet access provider, service provider, or other online organization that is responsible for assigning email addresses for the domain associated with the submitted email address. A potential Prize winner may be requested to provide the Sponsor with proof that he/she is the authorized account holder of the email address associated with the winning Game Play and that all eligibility requirements are met.

In the event a dispute regarding the identity of the individual who actually submitted a Game Play cannot be resolved to Sponsor's satisfaction, the affected Game Play will be deemed ineligible. The Releasees are not responsible for electronic communications that are undeliverable as a result of any form of active or passive filtering of any kind, or insufficient space in Entrant's email account to receive email messages. Also, the Releasees are not responsible, and may disqualify an Entrant, if his or her email address does not work or if it is changed without Entrant giving prior written notice to Sponsor.

No more than the stated number of Prizes will be awarded, and if there are more Prize claims received than the number of Prizes offered, the total number of Prizes stated shall be awarded via a random drawing from among all persons submitting Prize claims.

MISCELLANEOUS: The invalidity or unenforceability of any provision of these Official Rules will not affect the validity or enforceability of any other provision. In the event that any provision of the Official Rules is determined to be invalid or otherwise unenforceable or illegal, the other provisions will remain in effect and will be construed in accordance with their terms as if the invalid or illegal provision were not contained herein. Sponsor's failure to enforce any term of these Official Rules will not constitute a waiver of that provision. Participants agree to waive any rights to claim ambiguity of these Official Rules. Headings are solely for convenience of reference and will not be deemed to affect in any manner the meaning or intent of the documents or any provision hereof. In the event there is a discrepancy or inconsistency between disclosures or other statements contained in any Sweepstakes-related materials, privacy policy and/or the terms and conditions of the Official Rules, the Official Rules shall prevail, govern and control and the discrepancy will be resolved in Sponsor's sole and absolute discretion.

No Injunctive Relief: EACH PARTICIPANT UNDERSTANDS AND AGREES THAT HE/SHE SHALL HAVE NO RIGHT TO ENJOIN OR RESTRAIN THE DEVELOPMENT, PRODUCTION, ADVERTISING, PROMOTION, DISTRIBUTION OR EXPLOITATION OF THE SWEEPSTAKES OR ANY OTHER PRODUCT OR PROJECT OF SWEEPSTAKES ENTITIES OR ANY OF THEIR RESPECTIVE AFFILIATES.

DISCLAIMERS AND LIMITATION OF LIABILITY; DISCLAIMER OF WARRANTIES.
