Entry Period #8 ends at 11:59PM PT on April 3, 2018

In the event a Basketball Game is canceled for any reason, Sponsor (defined below) reserves the right to cancel a specific Entry Period, applicable Random Drawing and corresponding prizes and post notice of same at carmax.com/basketballsweepstakes (“Sweepstakes Site”).

The sponsor (“Sponsor”) of the Sweepstakes is CarMax Business Services, LLC, 12800 Tuckahoe Creek Parkway, Richmond, VA 23238. The Sweepstakes is subject to these official rules (the “Official Rules”) and by entering, entrant agrees to be bound by the terms and conditions herein and to all applicable federal, state and local laws.

ELIGIBILITY: Sweepstakes is open only to legal residents of the following California, USA counties: Imperial, San Diego, Riverside, Orange, San Bernardino, Los Angeles, Ventura, Kern, Santa Barbara, San Luis Obispo, Inyo, Tulare and Kings (collectively, the “Eligibility Area”), who as of the date of their Entry (defined below) into the Sweepstakes are eighteen (18) years of age or older. WINNER SELECTION AND NOTIFICATION: One (1) potential Grand Prize winner for each Entry Period will be selected in a Random Drawing from among all eligible Entries for that Random Drawing at or about the conclusion of the applicable Entry Period by an authorized representative of LA Clippers. The potential Grand Prize winners will be notified by LA Clippers by direct message (on the Social Media Platform entered), telephone and/or email within one (1) day of the applicable Random Drawing and will be required to provide complete contact information verify eligibility in the Sweepstakes within the time limit stated at time of notification or prize will be forfeited remain unawarded. Entry Period #9: 4/11/18 Game - The ARV is \$800
